The Activator

The Activator is a five-tier program, providing rigorous educational experience to future bioentrepreneurs. Our curriculum consists of bi-weekly workshops and culminates in a pitch event, during which finalists showcase their companies to industry stakeholders. Teams will finish with a polished pitch deck, written business plan, a fundraising and legal strategy, and a network of relevant industry advisors.



01 TEAM FORMATION

Align scientists and business students interested in launching a venture. Facilitate mutual matching



03 HANDS-ON WORKSHOPS

Iterate on science-first business theses; deep workshops with industry experts.



02 STRATEGY SUPPORT

Industry Mentors – Long-term guidance from experienced entrepreneurs & biotech executives.

Legal Strategy – Navigate the IP and corporate law landscapes with guidance from legal experts.

Clinical Partners – Work with clinical residents to explore unmet clinical needs and interview KOLs.

Workshop Structure •

Pre-work

- Before workshop, teams prepare slides and discussion
- Pre-work materials are circulated to the workshop experts in advance
- Slides will form components of the final 10-15 minute polished pitch deck presentation

Hands-on feedback

- Participation in two-hour workshops
- Teams are paired with experts relevant to their targeted market and/or technology
- Experts provide feedback on the materials presented by the teams

Post-work

- After workshop, teams integrate expert feedback
- Teams provide summary outlining what they learned & outstanding questions
- Post-work summaries will serve as building blocks for the final written business plan
