

Membership Growth in 2022





A year over year increase of 56%


Core Membership Summary


2022 iC³ Life Science and Healthcare Innovation Summit

iC³ = Innovation x Capital x Collaboration x Commercialization



Each company presents their successes, achievements, and how they continue to impact healthcare and the ecosystem in North Texas.





The BioNTX Tech Transfer Office Showcase (TTOS) highlights North Texas's strength in innovation while building future leaders and entrepreneurs. This program is designed to help North Texas based academic institutions showcase technologies that are available for licensing, collaboration and/or acquisition.

2022 BioNTX TTOS Winner

The University of Texas at Arlington's Venu Varanasi, PhD is developing biomaterials for craniomaxillofacial bone regeneration. He has created a way to use nanoparticles integrated with gelatin to 3D print bone-forming scaffolds to speed up the healing process from severe cranial and facial injuries.

\$8.8 M EDA Good Jobs Challenge Grant

BioNTX has received more than \$600,000 from the Economic Development Administration as part of a \$8.8M Good Jobs Challenge Grant to support an entry level workforce in 16 counties in North Texas. BioNTX joined Dallas College as well as the DFW Hospital Council Foundation and others in September 2022 to meet emerging workforce and skills needs while ensuring an industry-led development process. Formally titled 'Grow the Biotech Workforce in North Texas to Meet Emerging Skills Needs via a Collaborative Partnership', the initiative aims to train and place skilled workers in solid, well-paying jobs in Biotechnology and Healthcare-related fields.

To bring industry-sector employers to the table and ensure the creation of a robust training curriculum, educational programs, and viable career pathways; BioNTX has assembled the Biotechnology and Healthcare Industry Alliance of North Texas (BHIANT) in alignment with industry needs and priorities.

The BHIANT will operate with Dallas College and other partners in the Good Jobs Challenge Grant to develop an entry level workforce for the biotechnology and healthcare industries. The verticals included in this initiative are:



An accomplished scientist and physician, Dennis K. Stone was an instrumental figure in pioneering biotechnology development and advancement at UT Southwestern and in the Dallas-Fort Worth area.

BioNTX is proud to honor Dr. Dennis K. Stone, his memory, and work by annually awarding an individual who has positively affected the North Texas biotechnology industry and contributed awareness and funds to life science research and company formation.

Dennis was committed to the development of biotechnology in North Texas both as a faculty member of UT Southwestern and as the Chief Scientific Officer of Remeditex Ventures, a Dallas biomedical venture capital company.

About Dr. Guillem


Dr. Guillem was a veteran of the pharmaceutical industry with nearly 40 years of leadership experience in bringing new therapies to market and readying pharmaceutical manufacturing facilities for commercial production at both wellestablished and start-up companies. Dr. Guillem's previous experiences and successes include Co-founder, President, & CEO at ZS Pharma, a startup company developing a product for hyperkalemia or high levels of potassium in the blood. ZS Pharma was acquired by Astra Zeneca in 2015 for \$2.7 billion. Adams Respiratory Therapeutics, where he, along with other team members, brought the Mucinex product line to the market. The company later was acquired by Reckitt Benckiser for \$2.3 billion in 2007.



Year Over Year Revenue & Expenses


*During 2022, we were approved for a subaward under an Economic Development Agency Grant ("EDA Grant") of up to \$633,600, which will be recognized as revenue as the work is performed over an expected period of 3 years in accordance with the terms of the EDA Grant. During 2022, we recognized approximately \$6,000 of revenue from the EDA Grant.





Membership Revenue

Membership revenue (accrual basis) increased by \$84,630 year over year.
